FINANCIAL AND ENROLLMENT AGREEMENT 2022-2023

Please initial each section listed below, then sign and date at the bottom: There is a \$50 nonrefundable REGISTRATION FEE per family that is due at the time of registration. There is a \$100 nonrefundable BUILDING FEE per family that is due at the time of registration. There is a one-time non-refundable SUPPLY FEE that is due by May 1, 2022. The fee ranges from \$100 for two days a week to \$150 for four days a week. May, 2023 TUITION is due by May 1, 2022. The fee is non-refundable upon withdrawal, unless the child's spot is subsequently filled by another enrollment. Tuition is figured for the year and divided into 9 equal installments. Tuition is due at the first of the month beginning in September. Payments received after the 15th of the month will be assessed a \$10 late fee unless prior arrangements have been made with the Director. Tuition will not be refunded for days absent due to illness, vacations, snow days or other reasons. ____ If withdrawing from the program for any reason, written notification must be submitted to the Director at least two weeks in advance. I understand that I will be notified should my child become ill during the day and that I will pick up my child promptly. I will follow the procedures outlined in the Parent Handbook for bringing my child to school following an illness. The Learning Center follows Carmel Clay School calendar for major holidays. The Learning Center follows Carmel Clay School system for closures and delays in the event of inclement weather. A 2-hour delay will result in the preschool beginning at 10:30am. ____ I give permission for photos to be taken of my child and published on the website and other social media without name attached. You may provide my contact information to other parents within the Learning Center.
